



Snowbasin and Powder Mountain, Utah

TRIP SPONSORED BY - Meadville Ski Club
Saturday, February 25th – Saturday, March 3rd, 2012

COST: \$1095.00 per person (or less – see **NOTES below), double occupancy**

Deduct \$400.00 for no air, add \$150.00 for single supplement

Participants will have a 5 day lift ticket; two days at Powder Mountain and three days at Snowbasin. Both areas receive over 400 inches of powder snow each winter, have over 2600 lift served skiing acres, over 100 trails, and over 2200 vertical feet of skiing. Flights are available from Pittsburgh and Cleveland.

Accommodations:

- **La Quinta Inn, Layton.** Located on the edge of a large mall and near several chain restaurants. Indoor pool and dry sauna. Complimentary coffee service in the lobby and continental breakfast buffet is available daily. Welcome reception, complimentary. All guest rooms include cable TV/VCR, and free high speed internet access. Walk to many restaurants and shopping.

Trip includes:

- ◆ Round trip air transportation from Pittsburgh or Cleveland (15 spaces each) on American Airlines, leaving around noon through Chicago to Salt Lake City, arriving at 3:40 p.m. Return leaving at 8:30 am, arriving around 5 p.m.
- ◆ Round trip motorcoach transfer from airport to resort.
- ◆ 7 nights accommodation at La Quinta Inn, Layton (We've stayed there previously).
- ◆ 5 day lift pass to Powder Mountain (2 days) and Snowbasin (3 days).
- ◆ Daily round trip ground transfers from the La Quinta Inn to the mountain on private shuttle.
- ◆ Welcome reception & daily continental breakfast.
- ◆ All taxes and baggage handling.
- ◆ Other activities are in the planning stage for our "off day" such as a trip to the Solomon Activity center where you may fly in a wind tunnel, climb a rock wall, or surf. Could also ski another area or tour the Salt Lake City area. These will be at additional cost and information will be sent to participants.

Payments due as follows:

1. Initial deposit of \$150.00/ person by June 1st to reserve space for discount of \$25.00 (Total cost = \$1070.00). Deposits after June first will result in \$1095.00 trip cost.
2. Second payment of \$400.00 per person due September 9th.
3. Third payment of balance due December 15th.
4. Late payments will result in a \$20.00 surcharge.

REFUNDS:

All deposits are **fully refundable** until November 15, 2011. Refunds after this time will depend on availability from lodging and air. All refund requests must be made in writing to the Meadville Ski Club. Allow 3 - 4 weeks for refund. No credit or refund shall be granted for meals, services or lift tickets not taken or used. The Meadville Ski Club will charge a cancellation fee of \$20.00 above or beyond charges assessed by our suppliers should cancellation occur after the November 15th date.

TRIP INSURANCE:

We suggest using the optional trip insurance plan that is available through Travel Protectors LLC. Additional information will follow, but expected cost should be in the \$80.00 area.

NOTES

The \$25.00 discount is only available if the initial deposit is made prior to June 1st, 2011.

We may attempt to switch to Southwest Airlines when their schedule is released this summer, to eliminate the baggage charges. Until this air is finalized, it is suggested to not make reservations using frequent flier miles as ground transportation to our lodging depends on arrival time.

Meadville Ski Club Release Form

Said leaders are not professionally trained, but undertake the trip/activity leadership to the best of their knowledge and ability and spend many hours during and off-season, organizing, arranging and leading trips and events.

Release and Waiver of Liability and Indemnity Agreement to the Meadville Ski Club

I, the below named individual, being 21 years of age or older, in consideration of services which have been or will be performed by the Meadville Ski Club, in providing travel arrangements and activities and of being permitted to participate in the Club trips, activities, events and other functions which I recognize as being hazardous, do for myself, my personal representatives, and next of kin:

- (1) **hereby** release, waive, discharge and covenant not to sue or hold liable the Meadville Ski Club, its officers, directors, event leaders and trustees, all for the purposes herein, referred to as Releases, from all loss or damage and any claims or demands therefore, on account of injury to the person or property, or resulting in death, whether caused by the negligence of Releases or otherwise, while for any purpose participating in any event or activity; and
- (2) **hereby** agree to indemnify and save and hold harmless the Release from any loss, liability, damage, or the cost they may incur due to my presence and or participating during any activity, and whether caused by the negligence of the Release or otherwise; and
- (3) **hereby** assume full responsibility for any risk of bodily damage, death or property damage due to negligence of Release or otherwise while traveling, participating or for any purpose while engaged in such activities. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted in the state, states, and countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall continue in full legal force and effect.

I have read and voluntarily signed the Release and Waiver of Liability and Indemnity Agreement, which shall remain in full legal force and effect until such time that I notify the Meadville Ski Club in writing that this agreement is voided.
